Dear Ms Salas:

By this letter, Minnesota Public Radio ("MPR"), licensee of the above FM stations, hereby notifies the Commission that the remote control point for both stations is 45 East Seventh Street, Saint Paul, MN 55101, phone number 651-290-1500. This has been the remote control point for both stations since 1990.

MPR originally notified the Commission of this change of remote control point by letter dated October 16, 1990. A copy of that letter is attached herewith.

These two stations are co-located on the same tower in Rochester, MN. In 1997, upon registration of the tower, it was determined that the coordinates listed on the licenses for the two stations were incorrect. MPR thereafter filed minor modification applications for the stations to correct the coordinates of the tower. The Commission issued construction permits for the two stations with the correct coordinates. On August 6, 1998, the Commission issued a new license for KZSE and on February 8, 1999 the Commission issued a new license for KLSE. In both cases, the new licenses show the pre-1990 remote control points as the current control point for the stations.
