Request for Extension of Special Temporary Authority

Dear Ms Salas:

On behalf of Minnesota Public Radio ("MPR"), licensee of KNOW-FM, Minneapolis-Saint Paul, Minnesota, this is to request further special temporary authority to operate at variance with licensed parameters due to the temporary loss of antenna tower space. The current STA expires May 7, 2002.

As noted in MPR's original request for STA, dated July 19, 2000 and supplemented on October 13, 2000, KNOW-FM's antenna had to be relocated because of the planned construction of a new digital television station. Also, the tower site owner has made a commitment to MPR in writing of its intent to return KNOW-FM as promptly as possible to a new spot high on the current tower or on a neighboring tower.

As previously reported, since the initial STA was granted, the relocation has taken place and the parties are diligently working together towards a way to move KNOW-FM to a new high spot. Although MPR has taken all steps we can take on our own to expeditiously resolve the problem, plans have not yet been finalized. This move will affect numerous broadcasters in addition to MPR. Consequently, the coordination process is necessarily complex and requires additional time to complete. Many meetings and discussions have taken place between the engineers of the various broadcasters involved. As of last week, several of the broadcasters have agreed to move forward as soon as possible in pursuing a combined operation on the tower, which would result in MPR moving back up to its licensed height.

MPR therefore respectfully requests an additional grant of STA for KNOW-FM to continue to operate as described in its previous correspondence.
